2. Urgent Notice Final Deadline for Voters Register Update: Tonight, 11:59 PM WAT

The Committee wishes to remind all eligible members that pursuant to the Revised ECNBA Timetable issued on the 3rd day of July 2026, today **Thursday, 9th July 2026** is the final day for all corrections, updates, and complaints regarding entries on the Preliminary Voters Register.

All updates will close at midnight tonight 11:59 PM WAT, Thursday 9th July 2026. After this deadline, the Register will be cleaned up and frozen. No further additions, deletions, or amendments will be accepted under any circumstances.

Every eligible member is strongly urged to take the following steps before midnight tonight:

1. **Check that your name appears on the Register.** Visit the ECNBA website at ecnba.org.ng and search the Voters Register using your full name or Supreme Court Number (SCN).

2. **Confirm that your email address and phone number are correct.** Your voting One-Time Password (OTP) will be delivered to your registered contact details on Election Day. An incorrect email address or phone number means you will not receive your authentication token and will be unable to vote.
3. **Update your details immediately if anything is incorrect.** Use the self-service update portal on the ECNBA website. For corrections to your name, branch, or SCN, contact the ECNBA support immediately at support@ecnba.zohodesk.org.ng

Draw the attention of your colleagues to this notice. If you know a member who has not yet checked their details, please share this communication with them. No action can be taken after tonight.

Saturday, 18 July 2026	ELECTION DAY Voting opens 12:00 AM WAT. Voting closes 11:59 PM WAT.


